

# AHA NSW FOOTY TIPPING TERMS AND CONDITIONS DETAILS OF ENTRY

- 1. Information on how to enter and prizes form part of these Terms and Conditions of Entry.
- 2. Entry into the AHA NSW (Australian Hotels Association) Tipping Competition ("the Competition") is available to AHA NSW financial Members, staff, sponsors and associates of AHA NSW ("Venue") who have entered the Venue's local football tipping competition conducted via the Footy Tipping web address. Such members will automatically be entered into the Competition unless they advise the AHA NSW in writing that they do not wish to participate.
- 3. Entrants into the Competition must be a resident of Australia.
- **4.** Entry into the Competition commences on Wednesday 21 February 2024 and closes on the day that each Venue ceases to take entries into their local competition, but no earlier than Friday 19 April 2024.
- **5.** Entry into the Competition is FREE and only open to financial AHA NSW Members, staff, sponsors and associates.

### **RULES OF COMPETITION - TIPPING COMPETITION**

- 6. The basis of the main Tipping Competition will be Entrants making selections in each of the games for each of the 27 rounds of the home and away NRL season.
- 7. To participate in the Competition, Entrants must place their selections online via the AHA NSW website. Entrants' weekly selections will only be accepted if registered by the Entrant from 10:00 a.m. on the Tuesday immediately preceding each round of the season until 30 minutes prior to the commencement of each game in the round each week.
- **8.** The Tipping Competition commences on Friday 8 March 2024 and concludes at the end of the regular non final round of the NRL competition (round 27). Tips are to be made on all competition rounds (no tipping on Finals or State of Origin).
- **9.** Points for each game shall be allocated as follows;

Correct winning team selected : 1 point
Correct draw selected : 1 point
Losing team selected : 0 points

- Tips can be lodged until 30 minutes prior to the start of any game in the round. If any game has commenced before the Entrant's selections are registered, or if an Entrant fails to register their weekly selections for any game of any round during the relevant Weekly Selection Period, or if an Entrant's selections are not registered for any reason, the Entrant will automatically be credited with having selected the second named (away) team for any games for which a selection was not registered. In any one round, there is a maximum of 4 points for games in which selections were not registered.
- 12. Players must actively participate in the tipping competition to receive any prizes. If a player has not placed any tips for the year, they are ineligible to claim a prize.



#### **PRIZES**

#### **General Admission tickets**

- Tipsters with all correct selections in a round will go into a draw for select games General Admission tickets which will be allocated randomly throughout the competition.
- Prize pool may vary depending on what is available
- Prizes must be collected from the AHA NSW or arrangements must be made for them to be collected before the game otherwise the prize will be forfeited. The prize is not redeemable for cash

### Half round Leader

• The Entrant with the highest number of points after Round 14 on Monday 10 June 2024 will win 2x Ladbrokes Lounge tickets at Moonee Valley Racecourse, Victoria. Prize includes flights and accommodation.

## **Ampol State of Origin Reserved tickets**

- Wednesday 5 June 2024 at Accor Stadium
- Top 25% of tipsters (immediately before the draw) go into a draw to win the tickets.

### **Final Series tickets**

- Semi-finals will be played on the weekends of (TBC).
- Top 10% of tipsters (immediately before the draw) will go into a draw to win tickets to the finals. Each draw is made the Monday prior to the final.

#### Winner

• The Entrant with the highest number of points on Monday 9 September 2024 will be declared the Winner. The winner will receive 2 x tickets to the NRL Telstra Premiership Grand Final in Sydney NSW (Sunday 6 October 2024) which are reserved tickets.

Participants in this tipping competition acknowledge and understand that prizes may change and agree that such variations do not constitute grounds for dispute.

- 1. Prize winners will be notified by a phone call and/or email. If any person does not comply with these Terms and Conditions of Entry, the AHA NSW may refuse to accept or exclude any Entrant at any time. No responsibility is accepted for misdirected registrations or Entrant selections not included in the Competitions and the AHA NSW will not be liable for any claims or loss suffered as a result of exclusion of an Entrant or if any selections of an Entrant are not registered in the Competition for any reason.
- 2. Notwithstanding a person complying with these Terms and Conditions of Entry, the AHA NSW may refuse to accept or exclude any Entrant at any time. No responsibility is accepted for misdirected registrations or Entrant selections not included in the Competitions and the AHA NSW will not be liable for any claims or loss suffered as a result of exclusion of an Entrant or if any selections of an Entrant are not registered in the Competition for any reason.
- 3. The AHA NSW shall not be liable for any loss, damage or personal injury whatsoever which is suffered or sustained (including but not limited to indirect or consequential loss) as a result of taking a prize, except for any liability which cannot be excluded by law.
